

Pharmacy Update

Distribution Channels:

- Cardinal is allocating at 125% which resets weekly on Sunday, for items never purchased the allocation % is less.
 - If you need an allocation adjusted:
 - Work directly with Customer Service to create service ticket 800.926.3161 (GMB-P-CS-NA@cardinalhealth.com)
 - Provide following information the following information:
 - Account #
 - item #
 - Qty needed
 - Any other details relevant to the override request such as (patient need, treatment, etc)?
 - Customer service will submit a ticket to inventory manager at DC for review and then issue approval or denial
- Amerisource is allocating at the NDC level and it is not known what their allocation % is at this time. They post updates regularly at a dedicated microsite
- Baxter is allocating nearly all of their products now
 - o Recommending sites to go direct if they cannot get from wholesaler
 - The items with their allocation % are posted to the QHR Health COVID-19 Online Resource Center: Baxter Allocation Letter
 - Baxter has shared their allocations by site for the Mini Bags for the sites that purchase direct and that listing has been shared to the sites listed. If you have not received this list and would like to, please reach out to Stacy at sricharz@qhr.com
- *Piramal*, another sevoflurane vendor is not allocating and is working with Cardinal to not put strict allocations on their products.
- *Pfizer*, they are ramping up production and pulling forward production on Fentanyl 50ml and Propofol 100ml. They are requiring that you now order direct. To get propofol, please call their Supply Continuity Team at 844.646.4398.
- Fresenius Kabi, to purchase Propofol please contact Fresenius Kabi direct (Customer Service is 888.386.1300). You will need to have information on your current # of patients and your need.

Respiratory Process:

- Many of our sites use common cannisters and it is recommended that for patient safety we shift from shared inhalers to individual inhalers to reduce any risk.
 - Cardinal is limiting purchase of inhalers to sites that have not purchased them
 historically. They are sending surveys out now to help adjust AMU for historical
 Neb/Common Cannister sites.
 - Where we cannot convert to inhalers or MDIs, we will need to continue the use of Nebs, but work with respiratory and put in place procedures that limit the risk of exposure, filters for exhale, use in negative pressure when possible, and proper PPE being worn.
 - o If patient has own inhaler, consider them using their own.
 - Henry Schein does have some inhalers, MDIs/Spacers in stock. If you have a Schein account, please check it regularly



Supply issues for drugs:

- Healthtrust is working on securing some products for us to help with the short supply. Updates
 will be sent when that product is loaded to the Mckesson channel. If you do not have your
 Mckesson Channel account, please reach out to Stacy at sricharz@ghr.com
- It is recommended where possible a patient's own meds can be used. For example, if they already have an inhaler, they could use their inhaler.
- Drugs that may have or currently have supply issues:
 - o Azithromycin
 - o Cefepime
 - o Dexmedetomidine/Precedex
 - Doxycycline
 - Electrolytes
 - Famotidine IV
 - o Fentanyl
 - Hydroxychloroquine
 - o Inhalers/MDIs
 - IV Fluids Baxter has allocations in place, as do the wholesalers. If you have issues getting your normal 100% AMU from your wholesaler, please try Baxter direct.
 - o Levaquin
 - o Lovenox
 - o Meropenem
 - o Methylprednisolone
 - o Pantoprazole IV
 - o Penicillin
 - Propofol If you need Propofol, reach out to Fresenius Kabi direct (Customer Service is 888.386.1300). Please note there are reports of a 4-5 day lead time to receive product once ordered.
 - Their customer service will need to know specifics about the increased need. Do
 not say things like "we are expecting an increase" and use terms like "we have
 had a surge in utilization". Any specific numbers you can share will also help
 them determine need

Request can be submitted by patients physician to compassionateaccess@gilead.com. PPE for Pharmacy

- Please check the QHR Health COVID-19 Online Resource Center: COVID-19 Resource Center under supply chain and pharmacy for updates.
 - Information has been posted from Critical Point, USP and FDA on reusing PPE in pharmacy.
 - Updates from Cardinal and Amerisource are posted regularly. Look for the latest FAQ from your wholesaler for the latest update.
- Vendors to check regularly for PPE
 - o Cardinal & Amerisource, put in backorders as possible, allocations reset weekly
 - Henry Schein, they are no longer setting up new accounts. If you have an account:
 - Schein has Isolation gowns, gloves, masks, sanitizer and alcohol
 - Isolation Gowns limit is 5 packs per week
 - Gloves limit is 30 boxes per sku/90 boxes total per week
 - Procedural masks limit is 3 boxes every 5 days
 - Acute Care Pharmaceuticals
 - Can put on backorder at Cardinal Health
 - Their corporate office contact indicated sites may have success reaching out to their local rep and purchasing direct emergency supply if they have any stock on hand
 - Health Care Logistics
 - If a site has ever purchased any item with HCL, they can put in an order and it will go into backorder if it is unavailable.
 - They are filling backorders first as supply comes in and they are allocating to those backorders
- Ensure you have PPE for your pharmacy, if you are able to get extra please work with your Materials Management departments to help them out with any excess you can get.
